

SLOBODAN MILOŠEVIĆ

Srbijanski lider u vrijeme ratova devedesetih u Hrvatskoj, Bosni i Hercegovini i na Kosovu, koji je, između ostalog, pružao organizacijsku, logističku i političku podršku rukovodstvu samoproglasene Republike Srpske za vrijeme rata u Bosni i Hercegovini na čelu sa Radovanom Karadžićem i Ratkom Mladićem.

Leader of Serbia during the 1990s wars in Croatia, Bosnia and Herzegovina and Kosovo, who provided, among other things, organizational, logistical, and political support to the leadership of the self-proclaimed Republika Srpska during the war in Bosnia and Herzegovina, led by Radovan Karadžić and Ratko Mladić.
